

### Board Highlights - September 22, 2015

### **Executive Director Report**

Options for the future and viability of the Licensed Practical Nurses Foundation of Manitoba (LPNFM) were reviewed and discussed. The Board agreed to recommend that the LPNFM be dissolved and that the remaining funds be transferred to the Winnipeg Foundation. Annual scholarships and awards for LPNs and those entering the profession will continue to be granted, and an ad hoc committee will be struck to review criteria and make selections yearly.

The Board reviewed and approved changes to CLPNM policy R-10 Language Proficiency.

The Board directed the Executive Director to oversee the development and validation of a new Entry-level Competencies (ETPC) document. The Board also directed the Executive Director to continue revisions to the Competency Profile.
